To get best result of Yagya try to follow the instructions below –

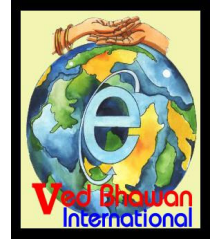
1. Keep aware that we can contact you in your given by any means of communication however we will try to consult your adviser first.

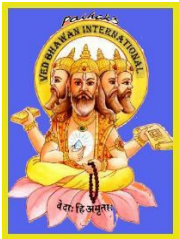

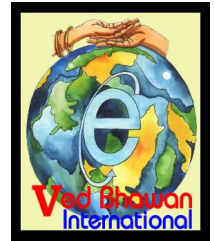

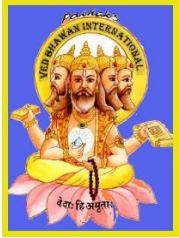

I also understand very well that Yagya is a spiritual activity and like the Pandits I also have good faith in Vedic Yagyas and Vedic Mantra. However I may expect betterment after performing the Yagyas but I shall not bind the organization and the Pandits or any the relevant person to certify the results in a visible mode. Moreover I also understand that Yagya only supports when I make efforts and hereby I also promise to do more then required efforts to make sure getting best support of Yagya.

## **Some standard but not limited terms and conditions, I agree that**

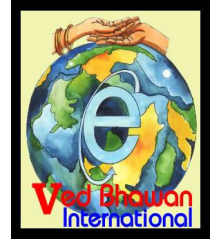
1. The Yagyas shall be performed according to the terminology, arrangements, standards, methods, definitions & regulations which is made by the Scholar Pandits of Ved Bhawan and partners and is revised time to time. I agree that any interference shall not be entertained.
2. The Yagya shall be absolutely religious and Ved Bhawan shall not include any black magic or such other stuffs, nor such pressure shall it accept too.
3. The Yagyas never supports for my negative intensions; I am aware that it is always positive. Likewise it gives more or less but always positive influence on the person for whom it has been performed.
4. The expectation what I have, is positive, possible, applicable on me and not an over-ambition or over-reaction of mine. I fully deserve for that and shall perform at full requirement or more if needed to achieve the target with help of Yagya.
5. I have contacted and requested for the Yagya myself and nobody has forced or insisted me to do this Yagya or to perform this with Ved Bhawan / Ved Bhawan International
6. I am also aware that in some cases Yagya doesn't work so much. Ved Bhawan or I, no one can make sure that the Yagya shall help. I still request for the Yagya understanding, better to have something than nothing or better to have tried than not tried.
7. The donations are spent over your Yagya, Pandits and other research works for further studies in the field of VEDA. Therefore I understand that it will absolutely not be possible to refund any part or total of the donation before or after the Yagya.
8. 11. In need the organization has right to bring a change in schedule, Pandits and Mantra or its quantity I will be informed.
12. I understand that according to Veda, Astrology and experiences, the Yagya normally doesn't work after its validity while it is possible that the problem is not completely resolved. In such cases I may advised to repeat or perform more / same Yagya to get proper effect, however I may decide myself whether to honor the advice or not.
